DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#103 is a 2-1/2 story, three bay square, brick home detached on the right (E) corner side with a 2-1/2 story brick "L" shaped wing, six bays long and 1-1/2 bays wide with a long side balcony and a small brick dependency.

The front brickwork is laid in Flemish bond and all other in common bond.

The rather plain Federal entranceway occupies the left bay with a large, four panel door, paneled enframing, four pane overlight with a wood lintel and a well-worn, white marble sill and low porch.

All house windows are of 6/6 sash with wood lintels and sills and louvered shutters. There is a six panel rear door.

The front roof section has a steep slope "A" frame roof resting on three string brick cornices, front and rear, and wide enclosed chimneys rise from each gable. The attic is lighted from the right by a 6/6 sash window similar to the others. The wing has a shed roof and both are of metal.

This house sets on a low fieldstone foundation. The front pavement is laid in a brick herringbone pattern. To the rear is a brick patio, boxwoods and lawn area.
