DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#329 is a 2-1/2 story brick house attached to a row of similar houses and is two bays wide and three bays in depth with a newer three story brick "L" shaped wing two bays deep and 1-1/2 bays wide with rear galleries. All brickwork is in common bond. The front entranceway occupies the right (N) bay with a four panel door with top panels rounded, a paneled enframement and a three pane overlight. All front windows are now of 1/1 sash with wood sills and moulded top lintels as over the door. The rear of the front section now has 1/1 and 2/2 sash windows and 6/6 sash on the wing, all with wood lintels and sills. The attic is well lighted by a peaked 6/6 dormer window on the front and rear. Because of the grade, the rear of the front section is 3-1/2 stories in height. This front section has a moderate slope "A" frame roof resting on three string brick cornices and a wide enclosed chimney rises on the left side. The wing roof is rather low and both are of metal. The building sets on a high fieldstone foundation which rises 8' from the rear level to the front pavement.
