DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This three story, brick building is a semi-detached house, three bays wide and four bays deep. Attached to the rear is a three story wing, two bays wide, and five bays long. A small, one story addition is attached to the rear of the wing. The main facade of the building is of Flemish bond and the remainder of the building in common bond, and the wing of common bond.

Side brickwork evidence shows this to have originally been a 2-1/2 story Federal shaped house. The main entranceway occupies the left (W) bay with a Federal, three part design, including a ten panel door, sidelights and overlights divided by attached Doric pillars and a paneled enframingent.

Front windows are of 1/1 sash on the first floor and 6/6 sash on the upper stories, all with louvered shutters and wood sills and lintels with top moulding.

A fieldstone foundation extends about 9-12" above the sidewalk. A small basement window with the same characteristics as the other windows is below the middle bay.

The house has a single brick chimney on the right end, center of the house, and the front roof slopes gradually to the rear, and the front roofline has a plain boxed cornice with a decorated frieze with the raking being plain.

A wooden bay window exists on the second and third floors above the door.
