DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a three story, detached pair of brick houses, four bays wide and approximately three bays in depth with a "T" shaped wing, two bays in depth and one bay wide and two stories for #123 and two deep, one wide and three stories for #125. Both houses have side balconies but those on #125 have been enclosed. All brickwork is of unpainted common bond. Rather simple front entrances occupy the end bays with large paned glass doors decorated by a row of small dentils under the glass and these doors are headed by double pane, segmental arched transoms. These are entered by three step brick porches with wrought iron railings. All front windows are of 2/2 sash with segmental arches and brick hood moulds centered by brick "keystones" of long shaped voussoirs as over the door. There is a double, segmental arched window on the side of #123 with a fluted mullion. All rear windows are of 6/6 sash with wood lintels and sills, and there are newer doors. The roof of the front section slopes to the rear with the wing of #123 having a shed roof and both are of metal. This building has a rather simple boxed cornice across the front roofline. It rests on a low fieldstone foundation and the front cellar windows are protected by cast iron grills with cherub heads, rather common in Frederick. There is a long lawn area to the rear of #125.
