DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#331 is a 2-1/2 story brick house attached to others in a row of similar houses and is three bays wide and approximately three bays in depth with a three story brick "L" shaped wing two bays wide and three in depth with side galleries. Because of the grade, the rear of the front section is 3-1/2 stories in height. All brickwork is in common bond. A round arched front doorway occupies the center bay with a newer paneled door and a large round arched 1/1 sash window lies to the right. On the left is a board and batten gate with a Victorian stickwork grill guarding steps leading down 8' to an enclosed passageway to the rear yards. Second story front windows are of 1/1 sash with wood sills and moulded top lintels. Rear area windows have 2/2 sash with wood lintels and sills and there are paneled doors with overlights. The attic is lighted by a large, Gothic pediment centered on the front roof with a 2/2 sash window. The high fieldstone foundation rises from the 8' deeper rear level to the front pavement.
