DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story brick pair of houses, detached on the left (E) side five bays wide (132 being three bays) and two bays in depth with two story, brick "U" shaped wings (134 partly frame), four bays in depth and two bays wide, with #132 having a rear balcony. All brickwork is of common bond. The left bay of #132 was added and of the same design. Simple front entranceways occupy the first and fourth bays from the left with #132 retaining the original four panel door and #134 has an original, three pane overlight. Both are entered by low brick porches with wrought iron railings. All windows are of 2/2 sash with wood lintels and sills, and #132 has some 6/6 sash on the side. The front section has a moderate slope "A" frame roof covered with asphalt shingles on #132 and by metal on #134. The wings have shed roofs. A small chimney rises from the left gable of #134. The front roofline rests on a three string brick cornice. This building sets on a low fieldstone foundation.
