DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a three story, "L" shaped building with six bays of four bays in depth fronting on Market Street and eight bays with the last four bays being two bays in depth and fronting on E. Third Street. Adjoining the east part of the building is a three story apartment house, approximately three bays wide and five bays in depth. This is known as #4 E. Third and was built separately but similar in design, height, and material to the corner structure. This corner building was designed to house a small "Frederick Trust Company" with apartments on the rear and upper floors. The junction of the north and west walls is angled with a one bay wide corner facade which sets the style for the entire building complex as turn-of-the-century, late Victorian.

This facade contains a two story high doorway with sidelights and overlights crowned by a Greek pediment of granite supported by brackets. Above this is a third floor window and continuation of the cornice which is ornamented by a second granite pediment. The Market Street facade contains a central doorway leading to a shop with display windows on either side, a paneled door on the south end for the apartments, and a two story high, three section, mullioned window on the north side next to the corner entrance. Third floor windows on the west corner and north facades are all singles with 1/1 sash. The Third Street facade also has two story high, mullioned windows being double in the center bays and triple on the ends. The East end bay has a glass over paneling door with overlight for the upstairs apartments. All streetside windows have flat, granite cornices with fan-shaped impost blocks and keystones. They also have granite sills.

A heavy, protruding cornice supported by wide brackets is mounted on an overlapping, three section frieze and extends across the two sides and corner. Above this is a Gothic battlemented brick parapet. This parapet has a flat top on the rear of the building and is topped by terra cotta. Two chimneys rise near the West front of the building. The roof is flat, but the material, not visible, is probably of tarred, crushed stone of that era. All streetside brickwork is in common bond, unpainted, and of a mustard yellow hue. The wall spaces between the Third Street top floor windows are adorned with flat, rectangular panels of a light yellow brick with designs of either crosses or diamonds. Rear windows are a mixture of 1/1 sash and 6/6 sash and with either wood lintels or two row brick header segmental arches. Second and third story balconies project from the rear. The foundation is not visible as it is faced to the pavement but is probably of fieldstone used in downtown Frederick at that time.

#4 E. Third Street, as previously mentioned, was built separately but of the same design and materials for all elements. The first floor has two, 1/1 sash windows and a gate to the rear with a glass paneled door in the East bay. This is approached by a three step cement porch. In the second and third floors, a three sided bay window section with 1/1 sash and bracketed cornice and a row of dentils occupies the West two bays. Single windows are above the doorway. This building also has 1/1 sash windows with segmented, two row brick header arches on the side and rear.
