**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

#333 is a 2-1/2 story brick house attached in a row of similar houses and is two bays wide and approximately three bays in depth with a two story newer block full width extension one bay deep. Because of the grade, the rear of the front section is 3-1/2 stories in height. All brickwork is in common bond. The front entranceway occupies the right (N) bay with a newer door and narrow overlight. First floor windows are of 1/1 sash with 2/2 sash above and all have wood sills and moulded top lintels. The attic is lighted by a small peaked 2/2 dormer window on the front. The house has a moderate slope metal "A" frame roof resting on three string brick cornices and shares a wide chimney with #335. The high fieldstone foundation rises from the 8' deeper rear level to the front pavement.
