DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story attached brick pair of houses four bays wide and approximately three bays in depth with a ^{two} story brick "T" shaped wing, three bays square and angled to the front section and with rear balconies (#14 enclosed). All brickwork is of common bond. Simple front entranceways occupy the center bays with newer glass over panel doors and two row brick header arches withinfills decorated by a roundel and panels. All front windows, including those of the basements, are also headed by these type arches. The front entrances are approached by marble sills and four step brick porches. Bay windows project from the second story end bays and are trimmed by grooved pilasters, dentils and panels. All windows are of 1/1 sash with brick segmental arches on the front and rear. The front section has a moderate slope "A" frame roof with #14 of slate and #14A of metal and a two string brick cornice supports the front roofline. This building rests on a high fieldstone and brick foundation.
