## DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a tall, three story attached pair of brick houses, six bays wide and approximately five bays deep with a nearby, full-width, two story, brick "T" shaped wing approximately four bays square which is angled to the front section and with rear balconies. All brickwork is of common bond. Round arched front entranceways occupy the inner bays with double doors of glass over panels, transoms with dentil trimmed transom bars, and white marble sills. These are approached by turn of the century, decorative, cast iron porches. On either side are wide windows and above these are bay windows trimmed by bracketed cornices, dentils and panels. All front and rear windows are of 1/1 sash with segmental brick arches of three row headers on the front and two row headers on the rear. Front windows have granite sills. The front roofline slopes to the rear and the wing has a low "A" frame. The front roofline cornice is rather modest with moulding and incised diagonals with three fluted brackets. This building rests on a high foundation with front cellar entrances half above ground level. There is a wide yard to the rear.
