DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a two story brick pair of houses attached on each side, four bays wide and approximately two bays in depth with a two story brick "T" shaped wing four narrow bays wide and two bays in depth with rear balconies. Narrow entranceways occupy the inner bays with paneled doors, rectangular transoms, dentiled transom bars, white marble sills, and segmental brick arches with infills decorated by a carved roundel and panels as are found on all front windows. These front windows are of 1/1 sash, being wider on the first floor, and most are protected by louvered shutters. Rear area windows are of 6/6 sash with wood lintels and sills and two row segmental brick arches. The front section roof slopes to the rear, and the wing has a low "A" frame, both of metal. A wide chimney is corbelled out from the center of the rear wall. The front roofline is decorated by a late Victorian "V" shaped cornice with bands of scallops, moulding, and incised crosses with very narrow moulded brackets at the ends. This building rests on a high fieldstone and brick foundation with the basement level 1/2 below ground level.
