DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a very large, three story detached pair of houses, approximately six bays square with a two story brick "T" shaped wing four bays wide and three bays in depth with rear galleries. All brickwork is of common bond with the front facade a light red shade of brick and rear areas being a darker red. A wide granite band crosses the building at the tops of the basement windows. Front entranceways occupy the center bays with simple, double glass over panel doors and wide transoms. There are bay windows in the end bays of the second story trimmed with moulding, dentils, pilasters, and panels. All front windows are of 1/1 sash with newer yellow brick soldier course, flat brick arches and sills. The third story of each house is topped by a brick pediment protruding from a slate mansard roof. These sections are lighted by small, round, four pane windows in the gables and by sets of three windows in a Palladian arrangement but separated by the brick wall. On the long sidewalls are simple and double 1/1 sash windows with segmental brick arches and those on the wing are of 2/2 sash, also with segmental brick arches. The front slate mansard section is enclosed by wide mouldings and ended by heavy moulded brackets. The roof of this section then slopes to the rear and the wing roof is rather flat. There are several sidewall enclosed chimneys on each side. This building sets on a rather high foundation.
