DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#26 E. Third Street is a rectangular shaped, three story, Flemish bond, flat roofed, detached house which faces north from the southeast side of E. Third St. It is a residential structure, non-related to adjoining structures. The first floor level is three bays wide. The main entrance door occupies the first bay of the southeast from the southeast corner and is decorated entablature, hood decorated and bracketed, below which are pilasters on either side of the door. There is a recessed segmentally-shaped glass window above a single double paneled door; above the panels in the door are two arched windows. Two window of a 7/1 sash* with arch radiating voussoirs and semi-elliptical arch occupy the second and third bays. At the second and third floor level are three similar windows to those on the first floor.

The roof cornice at the eaves level is boxed decorated, frieze decorated, with frieze brackets. The foundation is of stone. The steps are two in number and are concrete and granite stoop with wrought-iron railing.

ADDITIONAL INFORMATION:

This is a three bay square, brick detached building with a two story brick "L" shaped wing two bays wide and approximately five bays long with side and rear balconies with ornate Victorian cut banisters. Rear area windows are of 2/2 sash with wood lintels and sills.

The main entrance is framed by grooved pilasters with center blocks, has a granite sill and a heavy Victorian flat entablature richly decorated with 1/4 round dentils, scallops and incised panels.

The front roof section slopes to the rear and the cornice is of an elaborate Victorian design with floral bosses, scallops, pointed dentils, bays divided by moulded and grooved brackets and the spaces between have panels with incised designs.

The wing roof is rather flat. The building rests on a low foundation.
