DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#108 is a small, 2-1/2 story timber house, possibly of logs, but the present owner says nothing visible in the cellar, and the house is now covered by clapboarding. It is detached on the right side, three bays wide and two bays in depth with a two story, "L" shaped frame wing, 1-1/2 bays wide and four bays long. A small front doorway occupies the left bay with a newer door. All front windows are now 2/2 sash and rear area windows are 2/2, 6/6 and a small casement 3+3 window on the rear end. The wing has a four panel door. The front section has a steep slope "A" frame roof with a small chimney rising from the right gable. The wing has a shed roof and both are covered with asphalt shingles. These rooflines are enclosed by plain boxed cornices. The house sets on a low foundation.
