DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a three story brick pair of attached houses four bays wide and approximately three bays in depth. #343 has a three story brick full width wing three bays deep with large rear galleries partly enclosed. #345 has a three story one bay square frame "L" shaped wing. All brickwork is in common bond. Front entranceways occupy the right (N) bays of each house with newer doors, paneled enframements, and #345 retains a four pane overlight. Both are enclosed by Doric pilasters and overhanging flat entablatures. #345 is entered by an old ornate cast iron porch. #343 contains a large double 1/1 sash window beside the doorway with the mullion decorated by an attached turned newel post, and headed by a segmental brick arched transom of leaded stained glass in a design of overlapping lozenges with a roundel in the infill. #345 has a simple wide round arched 1/1 sash window beside the doorway. The upper story windows of #343 are of 1/1 sash with louvered shutters and #345 has 6/6 sash windows, all with wood sills and top moulded lintels. Rear area windows are mostly 6/6 sash and have wood lintels and sills. The front section roof slopes to the rear with deeply stepped sidewalls and the wing has a shed roof. The front roofline is decorated with an overhanging boxed cornice supported by closely spaced ornate moulded brackets with turned pendants and crockets bearing floral designs as on #347. This building rests on a low fieldstone foundation.
