DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#135 is a 2-1/2 story brick detached house, five bays wide and two bays in depth with a two story brick "L" shaped wing approximately four bays in depth and three bays wide which has been raised from one story according to sidewall evidence. There is a newer side extension to this wing. The front facade is laid in Flemish bond. A plain doorway occupies the central bay with a newer glass door, paneled enframing, and three pane transom. This is approached by a granite porch with wrought iron railings. Directly above this is a bay window with dentil trim. All front windows are of 1/1 sash with flat brick arches as over the doorway. All rear and side windows are of 6/6 sash with flat brick arches except for some second story windows with wood lintels and sills. The front section has a steep slope "A" frame roof resting on two string brick cornices, front and rear, and with wide enclosed chimneys rising from each gable. The wing has a shed roof and both are of metal. The attic is lighted by two small windows on each side. The building rests on a low foundation.
