DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#137 is a 2-1/2 story brick detached building located on an alley corner. It is three bays wide and two bays deep with a two story brick "L" shaped wing, three bays deep and two bays wide with a side balcony and first floor extension. All brickwork is of common bond. The first floor is occupied by a shop with a corner entrance and large paned windows topped by a boxed cornice. Above are three 6/6 sash windows with wood lintels and sills. Rear area windows are of 6/6 and 6/1 sash with wood lintels and sills and the attic is lighted by a small six pane window on either end. The front section has a steep slate covered "A" frame roof resting on a three string front and two string rear brick cornices. Double flue enclosed chimneys rise from each end. The metal roof of the wing is of shed construction. The house sets on a low foundation.
