DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story brick detached corner building now with two residences but formerly with a small grocery store in the right side, now 101A. It is five bays wide and two bays in depth with two story brick "U" shaped wings, three bays deep and two bays wide with a side balcony on #101 and rear balcony on 101A. All brickwork is of common bond. #101 has a plain doorway in the center bay and 101A has a newer doorway and retains the large pane 1/1 sash shop window. This is framed by fluted pilasters and topped by a plain boxed cornice. All front windows are of 1/1 sash with wood lintels and sills and most have louvered shutters. Rear area windows are a combination of 2/2, 6/6, and 6/1 sash with wood lintels and sills. The attics are lighted by small, four pane windows in each gable. The front section has a moderate slope "A" frame roof covered by asphalt shingles with a small enclosed chimney in the left wall, and another above the fourth bay from the left. The front roofline has a two string brick cornice. The wings have metal shed roofs. The building sets on a low fieldstone foundation.
