DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This building is a two story brick detached structure containing two residences. It is approximately four bays square with a two story brick "T" shaped wing two bays in depth and approximately three bays wide with side balconies and a two story brick newer rear extension being two bays deep on #203 and a one story frame extension on #205. All brickwork is of common bond. Front entrances occupy the end bays with glass over panel doors, transoms and segmental brick arches. Front windows are of 1/1 sash with segmental brick arches with carved roundels in the infills. There are louvered shutters on #203. Rear area windows are of 6/6 sash with wood lintels and sills. The front roof slopes to the rear and the wing has a low "A" frame roof, both of metal. The front roofline has a Victorian cornice shaped in a convex plane with closely spaced, fluted convex-curved brackets with carved roundels in between. The frieze is ornamented with a row of attached turned ballusters topped by a band of curved dentils with a band of sawtooth design at the bottom. There are long, fluted brackets at each end topped by a roundel. This building sets on a rather low foundation.
