DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#204 is a small, 2-1/2 story brick house detached on the left side. It is approximately two bays square with a two story "L" shaped wing, four bays deep and one bay wide with a side balcony. All brickwork is in common bond. The simple front entranceway occupies the right bay with a four paneled door, three pane overlight, and wood lintel. This is approached by a low concrete porch with a wrought iron railing. Front windows are of 2/2 sash with wood lintels and sills and louvered shutters. Rear area windows are all of 6/6 sash with wood lintels and sills and there are newer doors. The attic is lighted by two small 4/4 sash windows in the left gable. The front section has a moderate slope "A" frame roof of slate resting at least on the front on a three string brick cornice. There is a small enclosed chimney rising from the left gable. The wing has a metal shed roof. This house sets on a low fieldstone foundation. The front is enhanced by a herringbone brick pavement and there is a lawn area with evergreens to the rear.
