DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story brick detached pair of houses approximately four bays square with a two story brick "T" shaped wing two bays square with a side balcony remaining on #218. Simple entranceways occupy the end bays with newer doors and paneled enframements with rectangular transoms. #216 has 6/6 sash windows on the front with louvered shutters and wood sills and lintels--with moulded tops and small end brackets. #218 has had the first floor window lengthened, now has 1/1 sash and the same lintel design as #216 remaining on the second story only. Rear area windows are of 6/6 sash with wood lintels and sills and there are glass over panels doors with two pane overlights. All brickwork is of common bond. The attics are lighted by small 2/2 sash windows in each gable. The front section has a broad moderate slope "A" frame roof of slate resting on a three string front and two string rear brick cornices. Double flue enclosed chimneys rise from each end. The wing has a low "A" frame metal roof with a wide chimney on the rear. This building sets on a high fieldstone foundation.
