DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story frame detached pair of small houses, four bays wide and two bays in depth with a two story "T" shaped frame wing, four small bays wide and four bays in depth with rear balconies (#224 enclosed). The front and side facades are covered by clapboarding and the wing by what appears to be asbestos siding. Simple entranceways occupy the end bays with newer doors, a narrow overlight on #224 and #226 has a new classical enframing of fluted Doric pilasters and a broken pediment. All front windows are of 1/1 sash with louvered shutters. Rear area windows are of 2/2 sash and the attics are lighted by a small, four pane sash in each gable. The front section has a steep slope "A" frame roof with a double flue chimney rising from the center of the roofline. The boxed roof cornice is very attractive with a row of dentils, and it is supported by small moulded brackets with turned pendants dividing the bays, and they continue around the corners. The building sets on a rather low foundation.
