## DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#401 is a three story brick house attached on the left (S) side and is three bays wide and two bays in depth with a two story brick, full width wing with a newer third story rear extension. All brickwork is in common bond. The front entranceway occupies the left side bay with a newer door, paneled enframement, narrow overlight and all is framed by paneled pilasters topped by a flat entablature with dentil trim. This is approached by a low brownstone stoop. The first floor front has segmental arched 1/1 sash windows, the second story has regular 2/1 sash, and the third story has 2/2 sash windows, all with wood sills and lintels with moulded tops. The front section roof slopes to the rear and the roofline is decorated with an overhanging boxed cornice with moulded modillions and three large Victorian cut brackets. This building rests on a low fieldstone foundation.
