**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

#4 is a 2-1/2 story detached brick Federal house three bays wide and two bays deep with a two story, brick "L" shaped wing, five bays long, two bays wide and with a side balcony. All brickwork is in common bond. The front entrance-way occupies the right bay (W) with a Victorian, simple round arched passage of double doors of glass approached by a granite sill and a two step porch with wrought iron railings. This leads to a three part inner doorway with decorative mouldings in the egg and dart motif and other carved designs. All front windows are now of 1/1 sash with flat brick arches of long shaped voussoirs. Rear area windows are of 6/6 sash with wood lintels and sills. The attic is lighted by two small 6/6 sash in the left gable. The front section has a steep slope "A" frame slate roof resting on three string brick cornices, front and rear, and the sidewalls rise to form roof curtains with end buttresses. There are double flue enclosed chimneys rising from each gable. The wing has a shed roof. This old house rests on a low fieldstone foundation.
