DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#11 is a large, 2-1/2 story brick detached Federal house, four bays wide and two bays in depth with a two story brick "L" shaped wing, one bay deep and three bays wide and a two story brick extension which is two bays wide and approximately five bays long with a side balcony and a one bay square extension. All brickwork is in painted common bond. The front entranceway occupies the left (W) bay with a newer glass door, plain transom and approached by a new high brick porch. All front windows are now of 1/1 sash with louvered shutters and wood lintels as over the doorway. Rear area windows are mostly 6/6 sash with wood lintels and sills and louvered shutters. The front section has a moderate slope, slate covered "A" frame roof resting on three string brick cornices and with built-up sidewall roof curtains and end buttresses. A small enclosed chimney rises from the right gable. The attic is lighted by a small, four pane window in each gable. The wing has a shed roof. The house rests on a rather high fieldstone foundation. The brick pavement is in a herringbone pattern. There are lawn areas and flower gardens to the rear and a small detached brick dependency.
