DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#12 is a tall, narrow, three story brick detached building, three bays square with a two story brick "L" shaped wing, two bays wide and approximately six bays long with side galleries and a one story, two bay square, brick extension. All brickwork is in common bond. The front entranceway occupies the right (W) bay with double doors of glass, white marble sill, wide transom, dentiled transom bar, and approached by a white marble, two step porch with wrought iron railings. This is framed by ornately incised pilasters and a pedimented cornice centered by a floral design in high relief. This cornice design is used over all front windows. These windows are narrow, of 1/1 sash, and become shorter as they rise. Rear area windows are also of 1/1 sash and with regular wood lintels and sills. The front section roof slopes to the rear and the wing has a shed roof, all of metal. The front overhanging cornice is moulded and is above a high frieze with bays accented by long fluted and moulded brackets in panels in between. This building sets on a low fieldstone foundation.
