DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#18 is a 2-1/2 story brick Federal house built against #20 with a common wall and detached on the left (E) side. It is three bays wide and two bays deep with a two story brick "L" shaped wing, four bays deep with a two story brick "L" shaped wing, four bays deep and two bays wide with a side balcony and newer extension. The front facade has been restored chemically revealing a soft salmon hand-made brick, all in common bond. The front entranceway occupies the right bay with a newer door, three pane overlook and paneled enframingent. This is approached by a two step cast stone porch with rounded edges and an old cast iron railing , its mate destroyed in an accident. All front windows are now of 6/1 sash with moulded top wooden lintels and louvered shutters. Rear area windows are a combination of 9/1, 6/1 and 6/6 sash with wood lintels and sills and louvered shutters. The attic is lighted by a small 6/6 sash window in the left gable. The front section has a moderate slope "A" frame roof resting on three string brick cornices and a wide enclosed chimney rises from the left gable. The wing has a shed roof and both are of metal. This house rests on a low fieldstone foundation. There is a carriage entrance to the left of the house.
