DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#23 is a 2-1/2 story attached brick house, two bays wide and three bays in depth with a two story brick "L" shaped wing, two bays square beveled into the front section and with a rear balcony. All brickwork is in common bond. The front entranceway occupies the right (E) bay with double doors, granite sill and round arched transom. This is approached by an old ornamental cast iron porch with railings. To the left is a large, round arched 1/1 sash window and those on the second story front are also of 1/1 sash with louvered shutters and segmental arches of two row headers with the center of the lower row recessed as on #21. Rear area windows are of 2/2 sash on the first floor and 6/6 sash on the second floor, all with wood lintels and sills. There is a four panel door. The front section has a moderate slope "A" frame roof resting on two string brick cornices and with an enclosed chimney rising from the left gable. The attic is lighted by a peaked dormer on the rear slope. The wing has a shed roof and both are of metal. This house rests on a low fieldstone foundation. The front pavement is laid in a herringbone pattern of brick. There is a flower yard to the rear.
