DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#25 is a three story, three bay square brick house detached on the left (W) alley side with a two story brick "L" shaped wing, five bays long and two bays wide with a side balcony. The front facade is laid in Flemish bond through the second story and with sidewall evidence, this was originally a 2-1/2 story house. The front has been recently restored revealing old salmon colored brick. The front entranceway occupies the left bay with double doors of glass, a paneled enframement, granite sill and a wide transom. This is approached by a three step wooden porch with a side entrance and turned newel posts. This leads to an inner, three part doorway with double doors of beveled glass panes, sidelights and overlights--all in natural wood and intricately carved with the egg and dart motif mouldings. All front windows are now of 1/1 sash with louvered shutters and top moulded lintels as above the doorway. Rear area windows are a mixture of 6/6, 2/2 and 1/1 sash with louvered shutters and two row header segmental brick arches. The front section roof slopes toward the rear and the wing has a shed roof. The front roofline is adorned by a Victorian cornice with bands of moulding, dentils and scallops and the frieze is ended by a band of small spheres. This house rests on a low fieldstone foundation and is fronted by a herringbone design brick pavement.
