DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#102 is now a three story brick detached house, four bays wide and three bays in depth with a 2-1/2 story brick "L" shaped wing, two bays wide and four bays long with a side balcony. According to side and front wall evidence, this was formerly a 2-1/2 story house. The front facade is laid in Flemish bond brickwork through the second story, and all other is in common bond. The front entranceway occupies the second bay from the right (W) with a newer door and large transom. This is fronted by a classical appearing covered porch with a boxed cornice and supported by two pairs of octagonal Doric pillars on the front, and with square banisters on the sides. All house windows are of 6/6 sash with wood lintels and sills, except for several 1/1 sash on the wing and a rear bay window. First floor front windows are taller than those above, have wrought iron box grills and have louvered shutters. On the rear of the front section is a wide, two story bay window with 8/1 and 6/1 sash. The front section roof slopes to the rear and the wing has a steep slope "A" frame roof. The front roofline is ended by a simple boxed cornice with a wooden frieze rich with moulding. The house rests on a low fieldstone foundation. To the rear are lawn areas, evergreens, flowering shrubs and seasonal flowers.
