DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#103 is a new, three story detached brick house, three bays wide and approximately two bays in depth with a three story brick "L" shaped wing, two bays wide and seven bays long with side balconies and a three story brick, one bay square extension. According to sidewall evidence, this was formerly a 2-1/2 story home with a two story, two bay square wing. All brickwork is of common bond. The front entranceway occupies the left (W) bay with double doors of glass, white marble sill and a wide transom with a dentil trim transom bar. All house windows are now of 1/1 sash with those on the front headed by flat brick arches of shaped voussoirs, louvered shutters and appear to become shorter as they rise. Rear area windows have wood lintels and sills and some having louvered shutters. The front section roof slopes to the rear and the wing has a shed roof. There is a rather modest front roof cornice with bands of moulding, cross and "V" shaped incisions. Small moulded brackets accent the bays. This house rests on a low fieldstone foundation. There are lawn areas and flower gardens to the rear.
