DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a three story detached brick pair of houses, four bays wide and three bays in depth with a three bay wide "T" shaped wing of brick and two stories for #104 which is three bays long. #106 has three stories and is four bays long and both have second story side balconies. All brickwork is of common bond. Front entranceways occupy the inner bays with top rounded four panel doors and segmentally arched rectangular transoms. These are approached by white marble sills and two step granite porches with wrought iron side railings. All front windows are of 1/1 sash with segmental brick arches, and those on the first floor are protected by wrought iron box grills. #104 has louvered shutters on the upper stories. Rear area windows of #104 are mostly newer and #106 retains the 6/6 sash windows, all with wood lintels and sills. An older four paneled door also remains on #106. The front section roof slopes to the rear with rather small enclosed chimneys on each side, and the wing has a shed roof. The front cornice line is rather ornate with bands of floral motifs, pointed dentils, and the frieze is decorated by a band of incised crosses. Long moulded brackets divide the bays. This building sets on a low fieldstone foundation. To the rear of #104 are brick and stone patios and lawn areas with flower beds.
