**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This is now a three story brick house detached on the left (E) side and according to sidewall evidence, was formerly a 2-1/2 story house being built up in C1910. It is three bays wide and four bays in depth with a three story brick "L" shaped wing, five bays long and two bays wide with three story side galleries partly enclosed, and a three story brick, one bay square extension said by the owner to have been built up from an old brick stable. Front brickwork is of Flemish bond, and all other is in common bond. The main entranceway occupies the right (W) bay with a six panel door, paneled enframingent, a well worn, old white marble sill, and a tall, three pane overlight. This is entered by a one step porch with old heavy wrought iron side railings in a design of crosses. All house windows are of 6/6 sash with wood lintels and sills as above the doorway, and all windows have louvered shutters. The front mansard section is of 20th century design, being rather squarish and sheathed in metal. Three 6/6 sash windows appear to be suspended from the top and are covered by short shed roofs and moulded cornices. The front and rear section roofs are rather flat with the front section having pairs of enclosed double chimneys joined by curtains rising from the former side gables and with roof sidewall buttresses still showing. There is also a three string brick cornice remaining at the front roofline. This roof was originally of steep slope "A" frame construction. There is a side carriage entrance to the left and the whole is fronted by a brick pavement in a herringbone design. To the rear are landscaped brick patio areas and gardens with an outstanding collection of evergreens, perennials and seasonal flowers.
