DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a pair of three story brick houses detached on the right (W) side and is four bays wide and three bays in depth with a two story brick "T" shaped wing, three bays square with rear balconies (#112 enclosed). All brickwork is in common bond. Front entranceways occupy the inner bays with four panel (tops round arched) doors and segmental arched transoms with dentiled transom bars and granite sills. These are framed by narrow Doric pilasters and wooden top surrounds centered by wooden "keystones" and are approached by three step brick porches with wrought iron side railings. All front windows are of 1/1 sash with segmental brick arches and the upper story windows are protected by louvered shutters. There are the remains of first floor JIB windows on the rear of the front section, and all other rear area windows are of 6/6 sash with flat brick arches on the wing and wood lintels and sills on the rear of the front section, and all have louvered shutters. The front section roof slopes to the rear and the wing roof is rather flat. The front roof Victorian cornice is decorated by bands of finely cut chevrons and projecting roundels. This building sets on a rather low fieldstone foundation with the front cellar entrances one half above ground. The building is fronted by a herringbone patterned brick pavement and there are lawn areas and flower beds to the rear.
