DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a three story pair of brick houses detached on the left (W) side and is four bays wide and approximately three bays in depth with the upper stories supported on the front by square brick pillars fronting the porch. To the rear are three story brick "U" shaped wings, five bays long and 1-1/2 bays wide with rear galleries. The recessed front entranceways occupy the outer bays with glass doors and rectangular transoms. These are approached by a wide, divided porch covered by the upper stories. All front windows are of 1/1 sash with flat brick soldier course arches and concrete sills. Those on the upper stories are protected by louvered shutters. Wing windows are of 1/1 or 2/2 sash with brick segmental arches and louvered shutters. The roof of the front section slopes to the rear and the wing has a shed roof. The roofline is fronted by a plain overhanging boxed cornice. This building sets on a rather high foundation. The front facade is faced with a tan colored pressed brick, and all is in common bond. The front pavement is laid in a brick herringbone pattern.
