DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#116 is a three story Victorian townhouse, three bays wide and four bays deep with a two story, brick "L" shaped wing, five bays long and two bays wide with a side balcony and a two story, one bay square brick dependency extension. All brickwork is in common bond. The front entranceway occupies the right (W) bay with a large door of round arched panels, round arched side paneled enframement, a white marble sill, moulded transom bar and a two pane transom. This is enclosed by Doric pilasters and headed by a flat entablature with small cyma curved brackets. It is approached by a low brick porch with wrought iron side rails. First floor windows are of 1/1 sash and are taller than those above which have 6/1 sash. All have louvered shutters and very ornate, typically "Gingerbread" Victorian cornices with end blocks and intricate cut-out designs. Rear area windows are of 6/6 sash with wood lintels and sills and louvered shutters. There are four panel and newer doors on the wing. The front section roof slopes to the rear and the wing has a shed roof. The front roof cornice line is also typically Victorian with a row of closely spaced scrolled brackets and the frieze has a row of smaller, intricately cut brackets, etc. This house sets on a low fieldstone foundation.
