DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#119 is a low, two story brick house detached on the left (W) side. It is four bays wide and two bays in depth with a one story brick "L" shaped wing, five bays long and two bays wide with a newer frame second story and a recently built brick and frame rear extension. According to sidewall evidence, this was formerly a 1-1/2 story house with walls 14" thick. All brickwork is of common bond. The front entranceway occupies the third bay from the left with a newer door, a paneled enframement and formerly had a four pane overlight. This is now fronted by a small covered porch of classic design with a pediment, round arched in the center, supported by Doric columns and with side, square cut banisters. All front windows are now of 1/1 sash with wood lintels and sills and louvered shutters. There are 2/2 sash windows on the rear of the front section and all others are of 6/6 sash with old handblown glass on the first floor of the wing. The front section roof slopes to the rear and the wings have low slope roofs. The front roofline is decorated by a protruding moulded cornice with the frieze decorated by bands of dentils and beading. Small cut brackets divide the bays with large, more ornate brackets on the ends. This house rests on a low fieldstone foundation. There is a rear brick patio with an attractively designed flower and lawn area.
