DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#120 is a 2-1/2 story brick detached house, three bays wide and two bays in depth with a two story brick "L" shaped wing, six bays long and two bays wide with a side balcony, lower, two story, one bay square extension of brick and a small brick dependency. All brickwork is of common bond. The front entranceway occupies the left (E) bay with a four panel door, stone sill, paneled enframement, rectangular transom, and all enclosed by Doric pilasters with a moulded flat entablature. All front windows are now of 1/1 sash with moulded top wood lintels and sills. Wing windows are of 6/6 sash with wood lintels and sills, paneled shutters on the first floor and louvered shutters on the second story. There is a four panel door with a three pane overlight and the dependency has a board and batten door with half moon louvers. The attic is lighted by small 6/6 sash in each gable. The front section has a moderate slope "A" frame roof with double flue chimneys rising enclosed in each end. The wing has a boxed cornice trimmed by a row of large wooden dentils and the rear roofline rests on a two string brick cornice. This house sets on a rather low foundation. There is a lawn and flower yard to the rear.
