DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a three story detached pair of brick houses approximately four bays square with a two story, "T" shaped brick wing approximately three bays square and with no balconies. The front facade is faced with a light red pressed brick and all is in common bond. A two string belt course crosses the building above the cellar windows, in line with the upper story window sills and at the base of the frieze. Front entranceways occupy the outer bays with ornately paneled Victorian doors and scrolled transom bars. These are round arched and topped by unusual jack arches of header and stretcher brick voussoirs. The two inner bays have plain double windows with soldier course flat brick arches and sills. All front windows are of 1/1 sash with those on the upper stories having hood moulded segmental brick arches. There are 2/2 sash windows on the rear of the front section and 6/6 sash on the wings, all with wood lintels and sills. There are several four panel wing doors. The front section roof slopes to the rear, and the wing has a low "A" frame roof. The front roofline has an unusual cornice of eleven rows of corbelled bricks set in alternately protruding rows and decorated at the base by a band of alternately recessed bricks. The building sets on a low foundation. The front is paved by herringbone patterned brickwork.
