**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

#124 is a 2-1/2 story brick detached house, four bays wide and two bays in depth with a two story brick "L" shaped wing, four bays long and two bays wide with a side balcony and a small brick dependency. All brickwork is in common bond and according to sidewall evidence, the house may have been raised from 1-1/2 stories. The simple front entranceway occupies the third bay from the left (E) with a newer, large paned door, paneled enframing, and a narrow, one pane overlight. All house windows are of 6/6 sash with wood lintels and sills and there is a four panel door in the wing. The attic is lighted by a small, four pane window in the left gable and a small, three part 3+6+3 sash window in the right gable. The front section has a rather steep slate "A" frame roof, flattened to a low slope at the peak--unusual. This rests on a two string brick cornice. An unenclosed square chimney rises beside the left gable. The wing has a shed roof. The house rests on a low fieldstone foundation.
