DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#126 is a 2-1/2 story brick house detached on the left (E) side and is three bays wide and two bays in depth with a two story brick "L" shaped wing five bays long and two bays wide with a side balcony and the remains of a rear brick dependency. All brickwork is in common bond. The simple front entrance-way occupies the right bay with a newer door, paneled enframement, and a four pane overlight. All house windows are of 6/6 sash with wood lintels and sills and there is a four paneled door with a three pane overlight in the wing. The front section has a low slope "A" frame roof resting on two string brick cornices and a wide enclosed chimney rises from the left gable. The wing has a shed roof and both are of metal. This house rests on a low fieldstone foundation.
