DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#419 is a 2-1/2 story brick house detached on the left (S) side and is three bays wide and two bays in depth with a two story brick "L" shaped wing four bays deep and two bays wide with an enclosed side balcony and a one bay square brick extension. All brickwork is in common bond. The classical front entranceway occupies the right bay with a four panel door, paneled enframement, and overlight, and is framed by Doric pilasters supporting a flat entablature. First floor front windows are now of 1/1 sash with 6/6 sash windows on the second story and rear area and all have wood lintels and sills with the front lintels decorated by moulded tops. An old cast iron coal chute door projects from the front cellar wall. The attic is lighted by a four pane window on the left. The front section has a steep "A" frame roof resting on three string brick cornices and a double flue enclosed chimney rises from the left gable. The wing has a shed roof and both are of metal. The house rests on a low fieldstone foundation.
