**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This is a three story brick pair of houses, detached on the right (E) side and is four bays square with two story brick "U" shaped wings, two bays in depth and 1-1/2 bays wide with end balconies. All brickwork is in common bond and the front is faced with a cream colored pressed brick. Simple entranceways occupy the end bays with double doors of long panes and are topped by narrow transoms and wood lintels. These are approached by four step brick or cement porches with railings and white marble sills. First floor windows are quite wide and all house windows are of 1/1 sash with wood lintels and sills and those on the rear have louvered shutters. The third story mansard section is fronted by an unusual slate or tile material in a diamond shaped pattern. At the base is a three row brick cornice with the center row of alternately projecting headers. In the center third of each house, the front wall rises to carry full-sized windows and is topped by an overhanging pediment. The front section roof then slopes to the rear from the mansard and the wings have shed roofs, all of metal. This building rests on a high foundation.
