DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#129 is a three story attached brick house, four bays wide and three bays in depth with a two story brick "L" shaped wing five bays long and two bays wide with a side balcony and a two story, one bay square dependency extension. All brickwork is in common bond. The front entranceway occupies the left (W) bay with a shuttered newer paneled door, round arched transom, and broad moulded architrave. This is entered by a one step granite porch with ornate cast iron side railings. To the right is a double 1/1 sash elliptically arched window with a moulded mullion. In the right bay is an enclosed passageway to the rear gardens with a board and batten door and Victorian stickwork grill above. All other front windows are of 6/6 sash with louvered shutters and moulded cornices with protruding end blocks and ornamented by a band in a chain design as on its neighbor, #127. On the rear of the front section is an old 6/6 sash JIB window-door and all others are of 6/6 sash with wood lintels and sills. There are wing doors of four panels with four pane overlights, and the dependency has board and batten doors. The front section roof slopes to the rear and the wing has a shed roof. The front roofline is decorated by an overhanging moulded cornice supported by closely spaced cut brackets with turned pendants. The rear roofline rests on a two string brick cornice. The house sets on a low foundation. Front paving is of brick in a herringbone pattern. To the rear is a brick patio with a long narrow flower garden and a very large tree.
