**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

#9 is now a three story brick detached house three bays wide and two bays in depth with a three story brick "L" shaped wing, five bays long and two bays wide and side galleries. This was formerly of 2-1/2 stories with a two story wing, according to sidewall evidence. All brickwork is of common bond. The front entranceway occupies the left (W) bay with a newer door, white marble sill, newer granite porch and segmental arched transom. A two story bay window section projects above this trimmed with grooved pilasters and dentils. All other front windows are of 1/1 sash with segmental brick arches and segmental arched louvered shutters. Rear area windows are of 2/2 sash with wood lintels and sills and louvered shutters. The front section roof slopes to the rear with a small enclosed chimney on the right side and the wing has a shed roof. The front roofline has a rather simple overhanging cornice with a broad frieze and dentil trim. The building sets on a low fieldstone foundation.
