DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#13 is a two story, brick detached house, three bays square with a 2-1/2 story frame "L" shaped wing, six small bays in depth and two wide. This wing could be of an earlier period and is now covered by clapboarding on the first floor and asphalt shingles on the second story. Front section brickwork is of common bond. The front entrance occupies the left (W) bay with an ornate door of four panels trimmed with moulded inner panels and roundels. This is headed by a moulded transom bar of a scroll design in relief and has a segmental arched transom. Front and side windows are of 1/1 sash except for a 2/2 side window and they are headed by segmental brick arches of two row headers and there are segmental arched, louvered shutters on the front. Rear area windows are of small 6/6 sash. The front section roof slopes to the rear and the wing has a steep slope "A" frame roof, both of metal. The wing has an enclosed chimney on the end. The front roofline has a "V" shaped Victorian cornice with bands of incised crosses and other designs. This is ended by large, carved brackets bearing crockets of geometrical floral designs. The house rests on a low fieldstone foundation and is fronted by a herringbone patterned brick pavement.
