DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#14 is a 2-1/2 story detached brick house, four bays wide and two bays in depth with a two story brick "L" shaped wing, two bays wide and four bays long and a side balcony. The brickwork of the front facade is laid in Flemish bond. A simple front entranceway occupies the second bay from the left (E) with a newer paneled door and an old four pane overlight. All front windows are now of 2/1 sash and rear windows have 6/6 sash, all with wood lintels and sills. The rear door is also newer but retains a three pane overlight. The attic is lighted by a six pane window on the left and a small, four pane window in the right gable. The front section has a steep slope "A" frame roof resting on three string brick cornices. A double flue enclosed chimney rises from the right gable. The wing has a shed roof and both are of metal. This house rests on a low fieldstone foundation.
