**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

#15 is a 2-1/2 story, detached brick house, approximately three bays square with a two story, brick "L" shaped wing, two bays wide and five bays long with a side balcony. All brickwork is of common bond. The front entrance occupies the left bay with a newer door, white marble sill and segmentally arched transom. All front windows are now of 1/1 sash with segmental brick arches and have louvered shutters. Rear area windows are of 2/2 sash with wood lintels and sills and louvered shutters. The attic is lighted by small, four pane windows in each gable. The front section has a steep sloped "A" frame roof resting on a three string brick cornice on the front and a two string cornice on the rear. Double flue enclosed chimneys rise from each end. The wing has a shed roof and both are of metal. The house rests on a low fieldstone foundation.
