DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a pair of 2-1/2 story brick houses detached on the left (W) side, approximately four bays square with a two story, brick "T" shaped wing -- a slightly small, four bay wide and two bays deep with a rear balcony section and angled to the front section. The front is faced with a deep red pressed brick and the older side and rear brickwork is roughly laid, all in common bond. Simple front entrances occupy the outer bays with paneled doors and segmentally arched transoms. The bay windows above these doors are trimmed by grooved pilasters and dentiled cornices. Rising in the center above and between the bay windows is a steep gable section containing two small segmental arched windows and continuing the dentiled cornice trim. All house windows are of 1/1 sash with two row header segmental brick arches on the front and wood lintels and sills in the rear area. There is a two story bay window section on the side of #19 with the same trim as those on the front. The front section has a low slope "A" frame slate roof with a small chimney centered on the ridge. This building sets on a low fieldstone foundation and is fronted by a herringbone patterned brick pavement.
