DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story pair of brick houses detached on the right (E) side and approximately four bays square. #27 has a low frame extension and a second story frame addition with #29 having a two story, brick "L" shaped wing, two bays in depth and one wide. All brickwork is in common bond. Rather simple front entranceways occupy the inner bays with glass over panels doors, wood lintel and sill, and a four pane overlight. A wide covered porch fronts the building with turned pillars. The house windows are now of 1/1 sash with louvered shutters. The front section has a moderate slope "A" frame roof which levels off at the ridge to cover the raised rear area. There remains a two string brick cornice on the front. Double flue chimneys rise from each gable. The attics are lighted by small windows in each end. The wing of #29 has a shed roof. This building rests on a high fieldstone foundation.
